

1. Custom services The current approach and measures to combat the Corona virus ensures that can mediate under limited conditions to limited services.

1.1 With COVID19 and or flu symptoms of yourself and or roommates, there can not be mediated to an appointment.

1.2. No service to risk group due to Covid 19 virus. (Further on this page more about the risk groups)

1.3. Only by appointment, mediation can only be offered on pre-planned an agreement, whereby the rules of conduct of the rivm can be followed.

1.4. Appointments only 1 to 1, no couples, couples or duos.

1.5. Do not wear shoes on site.

1.6. On arrival: wash your hands with soap and water for 20 seconds, then hands dry well, wash towel after use. Do this before going outside, if you come back home after you blow your nose, of course before dinner and after you went to the toilet. Also when you enter Amsterdam Massage Center, this can on the toilet.

1.7. Cough and sneeze into the inside of your elbow

1.8. Use tissue paper to blow your nose and then throw it away, trash can on the toilet, then wash your hands again with soap for 20 seconds.

1.9. We don't shake hands

1.10. Masseur has a face mask on from your arrival until you leave. Talk like that less possible. This is not mandatory, but we deliberately choose to do so give cause and ensure your safety.

1.11. The masseuse will open doors for you, touch as little as possible, follow instructions from masseur.

1.12. Preferably contactless payment, either online in advance or with a strip card.

1.13. You may use a face mask, gloves or washed towels yourself if you feel more comfortable with it.

2 On location

2.1. Thoroughly clean door handles and washroom with soap.

2.2. Provide washed (unused) towels, wash towels and bath towels, linen washed at least 60 degrees.

2.3. Ensure a hygienic reception.

2.4. keep 1.5 meters away from where possible.

2.5. Air the reception area before the appointment.

3 Reception and during the appointment

3.1. Wash hands on arrival, under the watchful eye of your masseuse.

3.2. Dry hands with clean (unused) wipes, washed at 60 degrees.

3.3. Do not wear jewelry or as little items as possible.

3.4. If you wear a mask or gloves, these should not be worn to be

3.5. The masseuse takes her own towel, mask, gloves, and utensils for treatment.

3.6. You should behave passively during treatment.

4. Risk groups People who belong to a risk group are people who have a higher risk of becoming serious get sick from an infection with the new coronavirus.

These are:

People aged 70 and over

Adults (over 18 years old) with any of the underlying conditions:

People with chronic respiratory or lung problems who suffer so much from this have them under treatment by a pulmonologist. Chronic heart patients, who suffer from it so much that they are under be treated by a cardiologist.

People with diabetes who are ill-set and / or with complications.

People with kidney disease who have to dialyze or wait for a kidney transplant.

People with reduced resistance to infection because they take medicines to use for autoimmune disease and people who have an organ or have had a stem cell transplant.

People who do not have a spleen or a spleen that is not functioning and people who have a blood disease.

People with reduced resistance because they decrease resistance take medicine. Cancer patients during or within 3 months after chemotherapy and / or radiation.

People with severe immune disorders for which they need treatment from a doctor.

People with an HIV infection who are not (yet) being treated for a doctor or with an HIV infection with a CD4 cluster of differentiation 4 number below  $<200 / \text{mm}^2$ .

People with severe liver disease.

People who are very overweight (BMI Body Mass Index  $> 40$ ).

8. Customized services Following government action from Covid 19 in March this year, the sex workers and industry-related companies, like many other industries, all the way up to has come to a standstill. The noise of the vulnerable employees is extremely worrying because mainly consists of unskilled migrant workers with few job opportunities and are additionally affected financially due to the consideration that they are outside their own national borders have started working and this creates double fixed costs. The support of the government is nowhere near meeting the financial obligations. The current situation in the eyes of 365 entertainment and duchess escorts require one creative approach and support. Both to increase the chances of the

labor market as improving current income situation there is a retraining path up to relaxation masseuse/masseur offered to the mediated sex workers. In this way, the sex workers as certified masseuse/masseur with custom services to customers are mediated with strict observance protocol for different relaxation massages.
